


The University of Tartu

Founded in 1632 by the Swedish king Gustavus Adolphus, the University of Tartu is the oldest university in Estonia

The only classical university in the country, it is also Estonia's leading centre for research and higher education. In the most recent Times Higher Education University Rankings, Tartu sits among the top three per cent in the world.

The University has 13,000 students and 3,500 staff members across four faculties: Arts and Humanities, Social Sciences, Medicine, and Science and Technology. It enjoys bilateral cooperation agreements with 71 partner universities in 27 countries. Nearly 800 international students are studying for a degree in Tartu, and each year the University hosts up to 500 visiting exchange students.



The Conference's main venue: Lossi 36. Before the Social Sciences Faculty moved in four years ago, the building operated for nearly 140 years as a maternity hospital. Thousands of Estonians were brought into this world in the very rooms in which you will be attending Panels!

Dear graduate students and colleagues

This Conference represents a homecoming for many of us who have been involved with the ECPR for nearly 20 years.

Since joining the organisation in the mid-1990s, political scientists from Tartu have been going to a wide variety of ECPR events. We have contributed to the Consortium's journals. We have been members of its Standing Groups. We have served on Standing Group Steering Committees and even on the ECPR Executive Committee. But we had yet to host one of the Consortium's major events, until now.

The decision to bid for the Graduate Student Conference was an easy one. After all, summer is a beautiful time to be in Estonia! But also, given its cosy university atmosphere, Tartu is the perfect meeting place for graduate students, established scholars and guests. I encourage you to explore our historic buildings, enjoy our riverside attractions and get to know our country as a whole!

Over the years, political science in Tartu has also greatly

internationalised. Our staff colleagues now hail from 13 different countries, and our PhD and MA programmes are conducted entirely in English. Our research foci include EU-Russia relations, e-voting, post-communist democratisation and *de facto* states. We also have a policy studies unit.

As of January this year, we became the Johan Skytte Institute of Political Studies, in honour of the seventeenth century Swedish statesman and first Chancellor of the University of Tartu. Many of you may know the name from the Johan Skytte Prize in Political Science, awarded yearly by the Skytte Foundation at Uppsala University. This fact was a further reason for us to adopt the Skytte name, since the founder of modern political science in Tartu, Professor Rein Taagepera, was himself a Skytte Prizewinner in 2008.

So as we come full circle with our ECPR membership and now host the 2016 Graduate Student Conference, my thanks go to our excellent team – Siiri Maimets, Maili Vilson, Piret Ehin – and to Anna Foley and the entire ECPR Central Services staff.

We are grateful for the financial support received from the University of Tartu, the EU European Regional Development Fund and the city of Tartu.

And, of course, we thank all our terrific participants in advance for a wonderful conference!

The ECPR is an independent, scholarly association that supports and encourages the training, research and cross-national co-operation of political scientists through Europe and the world

Membership

ECPR membership is institutional and currently comprises nearly 350 universities concerned with the teaching and research of political science. Membership is paid by the university, but it is the individuals within it who receive the benefit; from Master's and PhD students, through to the most senior professor.

ECPR events

General Conference

The ECPR's General Conference is the largest annual gathering of political scientists in Europe, regularly bringing together some 2,000

scholars from across the world. The academic programme features around 60 Sections and over 400 Panels covering the full spectrum of political science and international relations, as well as an engaging Plenary programme of topical and high-profile lectures and Roundtables.

Joint Sessions of Workshops

Unique in format and considered the highlight of the annual international political science calendar, the Joint Sessions of Workshops have been held in a different European city every spring since 1973. The Joint Sessions remain extremely competitive, with only around 25

Workshops taking place and 15–20 participants per Workshop. Each participant must present a paper on the subject, which is then discussed in depth by the full group, proving an unrivalled opportunity for feedback and development of research.

Methods School

ECPR believes that good research requires solid methodology. Our biannual Methods School offers training across all methodologies, and caters to the needs of macro- and micro-level research. The courses, which can be followed on their own or combined over one or more events, cover quantitative and qualitative designs as well as positivist and interpretative perspectives.





The Winter School in Methods and Techniques takes place around February/March each year; the Summer School runs July–August. Combining the Summer and Winter Schools, you can follow training tracks to create a bespoke training package.

Graduate Student Conference

This event is an excellent opportunity for young scholars to share their work with peers in a supportive, stimulating environment. Students can take an active role in any capacity, or they can simply attend and observe.

A lively plenary programme includes roundtables on timely topics and professional issues facing students, lectures from high-profile academics, and social activities to grow the networks essential to a thriving career.

Research Sessions

The Research Sessions are a chance for small, pre-established groups to meet in a supported environment during the quieter summer months.

Whether it's an initial gathering to get a project off the ground, or a meeting further down the line to prepare a publishing proposal, groups are given the time and facilities they need to focus and move their project forward. Only groups from member institutions may apply, and priority is given to applicants from existing Standing Groups.

Publications

Journals and book series

ECPR co-publishes three leading journals: *European Political Science*, *European Journal of Political Research*, and *European Political Science Review*.

It also publishes the high-profile book series *Comparative Politics* with Oxford University Press.

ECPR Press

In 2005 the ECPR launched its own imprint: ECPR Press. The Press publishes high-quality *Monographs* and collections of *Essays*, along with a small selection of out-of-print *Classics* that have made a significant contribution to political studies scholarship.

The imprint also includes a highly respected series of multi-authored, edited volumes, *Studies in European Political Science*, many of which have developed from Workshops and Panels at ECPR events.

Standing Groups and Research Networks

The ECPR's Standing Groups and Research Networks are formalised groups of researchers that operate with the institutional support of the ECPR. Reflecting the breadth of the discipline, there are currently over 50 groups covering all sub-fields of political science and international relations. Anyone with an interest in that field can join a Group or Network and instantly connect with scholars working in their area through regular mailings, organisation of Sections, Panels or Workshops at ECPR events, annual meetings or even their own international conferences and summer schools.

Prizes

In recognition of the contributions made to all areas of political science, the ECPR awards ten prizes each

year. These recognise achievement at all stages of a scholar's career, including (for young scholars) the annual Jean Blondel PhD Prize awarded to the most outstanding thesis presented by a scholar at an ECPR member institution, and the Dirk Berg-Schlosser Prize for the best poster at the annual Summer School in Methods and Techniques.

Christian Welzel shows how interstate peace is underpinned by an increasingly pacifist force among the people of the world, making it harder for governments to find public support for war


The Kantian Peace Reinvented: The Emerging Mass Basis of Interstate Pacifism

Survey data from around the world evidence a massive decline in people's willingness to sacrifice their lives in war. To explain this finding, Welzel tests and confirms Evolutionary Emancipation Theory.

When improved conditions turn people's lives from threats to suffer into opportunities to thrive, people adopt 'emancipative values'. To allow themselves and others to enjoy life's wider opportunities, people increasingly support and tolerate universal freedom.

“people's willingness to sacrifice their lives in war has dramatically declined”

This emancipatory trend is most significant where the fixation of traditional survival norms on high fertility provoked the strongest resistance against emancipation: reproductive freedoms.



As a direct consequence of the emancipatory trend, people's willingness to sacrifice their own and other people's lives in war has undergone a dramatic decline.

Hence, the emancipatory trend is a pacifist force that makes it increasingly difficult for governments – especially in democracies – to find public support for waging wars.

The city of Tartu

Known as the capital of southern Estonia, Tartu is a vibrant city of learning with its own special spirit

Tartu is the oldest city in Estonia, first chronicled in 1030. Through the centuries it has been known variously as *Tarbatu*, *Dorpat* and *Yuryiev*, and during the fourteenth and fifteenth centuries it was part of the Hanseatic League. Today, it is the second largest city in Estonia with roughly 100,000 residents, a fifth of whom are students. Given its University connections, it has also been called 'Athens-upon-the-Emajõgi' or 'the city of good thoughts'.

The Emajõgi River cuts the city in half and shapes its districts and residents. Wars and fires have destroyed much of medieval Tartu, but the city has continually re-built and today successfully combines old and new: 200-year-old wooden houses together with contemporary architectural design, historic university buildings with modern campus ensembles.

Tartu has also been a cradle of Estonian nationhood, spawning numerous cultural figures, intellectuals and social activists during the nineteenth and twentieth centuries.

In 1869, Tartu was the site of the first Estonian Song Festival that began

a unique tradition of national choral singing that continues to this day. It has also played a role politically, most recently spearheading parts of Estonia's re-independence movement.

Tartu's Old Town

Since the thirteenth century the heart of Tartu has been its Town Hall Square. Here we find not only the seat of municipal government, but also the Kissing Students fountain, a more recent landmark unveiled in 1998.

The Town Hall building itself dates back to 1789. Its carillon of 18 bells adds a special musical air to the city every day at noon.

Toomemägi (Dome Hill)

Toomemägi is home to the Dome Cathedral, the Tartu Observatory, the Old Anatomicum, and the Angel's and Devil's bridges. It is also the location of the University's Social Sciences Faculty building, Lossi 36. See page 4 to find out more.

As you stroll around Dome Hill, be sure to climb the towers of the Dome Cathedral for a panoramic view of the city! Also pay homage to (the statue of) Professor Karl Ernst von Baer, the nineteenth century embryologist, whose hair university students faithfully clean with champagne each year on 30 April.

Neighbourhoods

Outside the downtown area, discover the neighbourhoods of Supilinn and Karlova. Supilinn (Soup Town) derives its fame from the names of its streets: Herne (pea), Kartuli (potato),

Oa (bean), etc. Karlova, meanwhile, grew out of a nineteenth century manor complex you can still see today. Both offer a glimpse of Tartu as it was a century ago, with cozy wooden houses and residential flair.


Museums

University Main Building

As the national university of Estonia, the University of Tartu is epitomised by its Main Building with its classicist architecture and six white columns.

Constructed in 1809, the building is home to three visitor attractions: the University Art Museum, the stately Assembly Hall (*Aula*) and the Student Lock-up, where students were incarcerated for minor offences in the nineteenth century.

This Building will be the location for the Plenary Session and Roundtables at the Graduate Student Conference.

Roundtables

Roundtable 1

How to Get Published

Tuesday 12 July, 11:15–12:45,
Aula, University of Tartu

Focusing mainly on publishing in international academic journals, this Roundtable will address issues such as how to choose a journal, how to deal with peer reviews, and how to reckon with long delays. You will hear from scholars who have published numerous peer-reviewed articles, as well as those who have served as journal editors.

Eiki Berg, Professor of International Relations at the Skytte Institute of Political Studies, University of Tartu. Has published nearly 30 articles, in *Journal of International Relations and Development*, *International Studies Perspectives*, *Geopolitics*, *Nations and Nationalism*, *Cooperation and Conflict* and *Europe-Asia Studies*, among others. Professor Berg will address differences in area studies, journals versus disciplinary journals, and differences across sub-fields.

Christian Welzel, Leuphana University Lüneburg. Over the last 20 years, Welzel has published over 60 journal articles in a wide range of journals, in English and German. He will focus on what it takes to get into the very top journals, as well as cross-cultural differences in publishing.

Carlos Closa Montero, Research Area Director at the Global Governance Program, European University Institute. Professor Montero is co-editor of the ECPR journal *European Political Science Review*. He will speak on how a journal editor screens manuscripts, recruits reviewers and communicates with authors.

Roundtable 2

How to Write a Research Proposal

Tuesday 12 July, 16:30–18:00,
Aula, University of Tartu

This Roundtable advises on putting together research proposals for national and international funders. Speakers will be asked to discuss a variety of proposal types, including dissertation proposals, post-doc applications, and project funding applications, where applicable.

Katrin Uba, Associate Professor in Political Science, Uppsala University. Professor Uba's research focuses on protest mobilisation, social movement outcomes and the labour movement in Sweden and beyond. Her research has been funded by the Riksbankens Jubileumsfond, the EU's FP7 programme, the Swedish Research Council and the Swedish Energy Agency.

Kristjan Vassil, Senior Researcher at the Skytte Institute of Political Studies and Vice-Dean for Research and Development, University of Tartu. A graduate of the European University Institute in 2012, Vassil went on to obtain a postdoctoral position back in his native Estonia, where he has since applied successfully for five research grants, including most recently a €1m grant to create a Center for IT Impact Studies.

Hector C. Pagan, Lecturer at the Skytte Institute of Political Studies. For more than 20 years, Hector Pagan has written funding proposals in the US and Estonia. He has raised over €9 million, writing EU funding proposals in consultation with researchers and practitioners in a wide range of fields.

Roundtable 3

Russia and the West: What's the Temperature in the Baltics?

Wednesday 13 July, 11:15–12:45,
Aula, University of Tartu

Discussion of relations between Russia and the West from a Baltic point of view. How has the Ukraine conflict played out in this region? How have developments affected views on the EU and NATO? How do Baltic Russians feel about the current state of affairs? What is the place of the Baltic states in Russian-European relations: a precarious borderland, a security bulwark or an intermediary player?

Piret Ehin, Director of the Center for EU-Russia Studies and Senior Researcher, University of Tartu. Has written on Baltic-Russian relations in academic publications and policy reports for EU institutions.

Viacheslav Morozov, Professor of EU-Russia Studies, Skytte Institute of Political Studies, University of Tartu. Professor Morozov was previously associate professor at St Petersburg State University. His most recent book is *Russia's Postcolonial Identity: A Subaltern Empire in a Eurocentric World* (Palgrave Macmillan).

Brian Whitmore, Senior Editor and Russia analyst for Radio Free Europe/Radio Liberty. Brian is the author of *The Power Vertical Blog* and *The Power Vertical Podcast*, which focus on Russian affairs. Prior to joining RFE/RL in 2007, Brian worked for the *Boston Globe*, first in the *Globe's* Moscow bureau and later as Central and Eastern European correspondent based in Prague. Before this he was a political correspondent and columnist for the *Moscow Times* and its sister publication the *St Petersburg Times*.
